- The Society of the Revival of Islamic Heritage to the Al-Fitrah Institution:
- \* The cooperation between the Society of the Revival of Islamic Heritage and Al-Fitrah Institution was in the field of propagation and education through contributing in buying the center used for this purpose
- \* The cooperation with Al-Fitrah Institution was because it is an official Dutch institution recognized by the Dutch laws (attached herewith is a copy of a certificate of good conduct issued by the Ministry of Security and Justice of the Netherlands).
- \* All Kuwaiti charity organisations were instructed not to deal with Al-Fitrah Institution based on a request from the Dutch authorities. This request was accepted due to the strong relations between the two countries.
- \* We would like to reiterate that all charity organizations are active in the field of youth awareness and combating extremism and terrorism. Those organizations have the trust of the Kuwaiti government.
  - All persons in charge of the Kuwaiti charity organizations are known of moderation and they have clear efforts in combatting extremism. The Kuwaiti government relies on them in spreading moderate ideologiy of Islam.

With regard to your inquiry on possible Kuwaiti financial links with 'Eid Charity' in Qatar, 'Al Nour Stiftung' in Heidelberg Germany, the Ministry will look into this and provide you with the information as early as possible.

The Ministry avails itself of this opportunit to renew to the Embassy the assurances of highest consideration.
